## CabWriter Software License Agreement

Welcome to CabWriter. This CabWriter Software License Agreement (the "Agreement") is a legal agreement between the individual, or the company or other organization on whose behalf such individual accepts this Agreement ("You", "Your" or "Yourself") and CabWriter Software LLC ("CabWriter"). By downloading, installing or using CabWriter software or any portion thereof (the **"Software"**) You hereby agree to be bound by the terms and conditions (the **"Terms and Conditions"**) contained in this Agreement and represent that You are authorized to do so. If You are a business entity, You also represent that You are duly authorized to do business in the country or countries where You operate and that Your employees, officers, representatives, and other agents accessing the Software are duly authorized to access the Software and to legally bind You to these Terms and Conditions.

### 1. USE OF THE PRODUCTS

In exchange for Your payment of the license fee, CabWriter grants to You a worldwide, limited, nontransferable and non-exclusive license to use the Software solely in accordance with the Terms and Condition herein (the "License"). The License is limited to a single user (the "Permitted User"). The Permitted User may install and use the Software on one desktop device and one portable device (laptop or tablet), provided however, that both devices are owned by the Permitted User. You hereby warrant that You or the Permitted User, as applicable, have a valid and appropriate license to use SketchUp and that You will maintain such valid license to use SketchUp for the full term of this License.

#### 1.1. Restrictions

You shall not permit any person other than the Permitted User to access or use the Software. You shall not, and shall not permit the Permitted User or any third party to:

- (i) modify or create a derivative work of any part of the Software;
- (ii) rent, lease or loan the Software;

(iii) use the Software, or permit it to be used, for third-party training, to deliver software implementation or consulting services to any third parties, or for commercial time-sharing or service bureau use;

(iv) disassemble, reverse engineer or decompile the Software or the file format of the Software, or otherwise attempt to gain access to or extract the source code or file format of the Software, unless expressly permitted by CabWriter, in writing or required by law;

(v) sell, license, sublicense, loan, rent, lease, assign, or otherwise transfer (whether by sale, exchange, gift, operation of law, or otherwise) the Software to any third party, any copy thereof, or the License or other rights thereto, in whole or in part, without in each case obtaining the prior written consent of CabWriter; (vi) alter, remove, or obscure any copyright, trade secret, patent, trademark, logo, proprietary and/or other legal notices on or in any copies of the Software;

(vii) copy or otherwise reproduce the Software in whole or in part, except (a) as may be required for Your installation into computer memory for the purpose of executing the Software in accordance this Agreement, and/or (b) to make a reasonable number of copies solely for back-up purposes (provided that any such permitted copies shall be the property of CabWriter and You shall reproduce thereon all CabWriter copyright, trade secret, patent, trademark, logo, proprietary and/or other legal notices contained in the original copy of the Software obtained from CabWriter); and

(viii) You may not remove any product identification, proprietary, copyright, or other notices contained in the Software.

## 1.1.1. CabWriter Home

CabWriter Home Software is licensed only for non-commercial use. Non-commercial use means that the License is for Your own personal use and not for use in the operation of a business or service bureau, for profit or for the benefit of any other person or entity. Any other use requires the purchase of a CabWriter Pro license. For example, if You are a for-profit organization of any kind, or an employee or contractor of a for-profit organization using the Software in that capacity, You are engaged in commercial activity. In those circumstances, You must purchase a CabWriter Pro license in order to use the Software. Government agencies are considered to be commercial users and must purchase a CabWriter Pro license.

# 1.1.2. CabWriter Pro and CabWriter CNC

CabWriter Pro and CabWriter CNC Software may be used for commercial purposes in accordance with the Terms and Conditions of this Agreement.

# 2. PROPRIETARY RIGHTS

You acknowledge that (a) the Software contains proprietary and confidential information that is protected by applicable intellectual property and other laws, and (b) CabWriter owns all right, title and interest in and to the Software and certain software provided through or in conjunction with the Software, including without limitation all Intellectual Property Rights therein and thereto. **"Intellectual Property Rights"** means any and all rights under patent law, copyright law, trade secret law, trademark law, unfair competition law, and any and all other proprietary rights, and any and all applications, renewals, extensions and restorations thereof, now or hereafter in force and effect worldwide. All copies of the Software, in whatever form provided by CabWriter or made by You, shall remain the property of CabWriter, and such copies shall be deemed to be on loan to You during the term of Your License. You acknowledge that the License granted hereunder does not provide You with title to or ownership of the Software or any copies thereof, but only a right of limited use consistent with the express Terms and

Conditions of this Agreement. You shall have no rights to the source code for the Software and You agree that only CabWriter shall have the right to maintain, enhance, or otherwise modify the Software. You agree that You will not, and will not allow any third party to (i) take any action to circumvent or defeat the security or content usage rules provided, deployed or enforced by any functionality (including without limitation digital rights management functionality) contained in the Software, (ii) use the Software to access, copy, transfer, transcode or retransmit content in violation of any law or third party rights, or (iii) remove, obscure, or alter CabWriter's copyright notices, trademarks, or other proprietary rights notices affixed to or contained within or accessed in conjunction with or through the Software.

## 3. COMPLIANCE WITH LAWS

You agree to comply with all laws and regulations regarding the download, installation and use of the Software.

## 4. TERMINATION

The License is effective until terminated. You may terminate these Terms and Conditions at any time by permanently deleting all copies, full or partial, of the Software in its entirety. Your rights automatically and immediately terminate without notice from CabWriter if You fail to comply with any provision of these Terms and Conditions, including the timely payment of the licensing fee. In addition, CabWriter may terminate Your rights under this Agreement at any time without prior notice. In the event Your rights under this Agreement are terminated, You must immediately cease all use of the Software and permanently delete all copies, full or partial, of the Software.

# 5. INDEMNITY

You agree to hold harmless and indemnify CabWriter and its subsidiaries, affiliates, officers, agents, and employees from and against any claim, suit or action arising from or in any way related to Your use of the Software or Your violation of these Terms and Conditions, including any liability or reasonable expense arising from all claims, losses, damages, suits, judgments, litigation costs and attorneys' fees, of every kind and nature. In such a case, CabWriter will provide you with written notice of such claim, suit or action.

## 6. DISCLAIMER OF WARRANTIES

YOU EXPRESSLY UNDERSTAND AND AGREE THAT:

a) YOUR USE OF THE SOFTWARE IS AT YOUR SOLE RISK. THE SOFTWARE IS PROVIDED ON AN "AS IS" BASIS AND WITHOUT WARRANTY OF ANY KIND. TO THE MAXIMUM EXTENT PERMITTED BY LAW, CABWRITER EXPRESSLY DISCLAIMS ALL WARRANTIES AND CONDITIONS OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO THE IMPLIED WARRANTIES AND CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT.

- b) CABWRITER MAKES NO WARRANTY: (I) THAT THE SOFTWARE WILL MEET YOUR REQUIREMENTS, (II) THAT THE SOFTWARE WILL BE ERROR-FREE OR BUG-FREE, (III) REGARDING THE SECURITY, RELIABILITY, TIMELINESS, OR PERFORMANCE OF THE SOFTWARE, (IV) THAT ANY ERRORS IN THE SOFTWARE WILL BE CORRECTED AND (V) REGARDING THE RESULTS OR OUTPUT OF THE SOFTWARE, (V) THAT YOU WILL ACHIEVE ANY PARTICULAR RETURN ON INVESTMENT, (VI) THAT ANY CABINET OR OTHER BUILDING PROJECT CREATED USING THE SOFTWARE WILL BE SAFE, STRUCTURALLY SOUND, OR MEET ANY GOVERNMENT OR WORKPLACE SAFETY CODE.
- c) ANY CONTENT OR MATERIAL DOWNLOADED OR OTHERWISE OBTAINED THROUGH THE USE OF THE SOFTWARE IS DONE AT YOUR OWN DISCRETION AND RISK AND YOU WILL BE SOLELY RESPONSIBLE FOR ANY DAMAGE TO YOUR COMPUTER SYSTEM OR OTHER DEVICE OR LOSS OF DATA THAT RESULTS FROM THE DOWNLOAD OF ANY SUCH CONTENT OR MATERIAL.
- d) NONE OF THE SOFTWARE IS INTENDED FOR USE IN THE OPERATION OF NUCLEAR FACILITIES, LIFE SUPPORT SYSTEMS, EMERGENCY COMMUNICATIONS, AIRCRAFT NAVIGATION OR COMMUNICATION SYSTEMS, AIR TRAFFIC CONTROL SYSTEMS, OR ANY OTHER SUCH ACTIVITIES IN WHICH CASE THE FAILURE OF THE SOFTWARE COULD LEAD TO DEATH, PERSONAL INJURY, OR SEVERE PHYSICAL OR ENVIRONMENTAL DAMAGE.
- e) NO ADVICE OR INFORMATION, WHETHER ORAL OR WRITTEN, OBTAINED BY YOU FROM CABWRITER OR ANY THIRD PARTY OR THROUGH THE SOFTWARE SHALL CREATE ANY WARRANTY NOT EXPRESSLY STATED IN THESE TERMS AND CONDITIONS.

## 7. LIMITATION OF LIABILITY

THE MAXIMUM LIABILITY OF CABWRITER AND ITS AFFILIATES, OFFICERS, AGENTS AND EMPLOYEES, ARISING OUT OF, OR RELATING TO, THE CREATION, LICENSE. FUNCTIONING. USE OR SUPPLY OF THE SOFTWARE OR OTHERWISE RELATING TO THIS AGREEMENT, WHETHER BASED UPON WARRANTY, CONTRACT, TORT, OR OTHERWISE, SHALL NOT EXCEED THE FEES PAID BY YOU FOR THE SOFTWARE THAT GAVE RISE TO THE CLAIM. YOU EXPRESSLY UNDERSTAND AND AGREE THAT CABWRITER SHALL NOT BE LIABLE TO YOU FOR ANY DIRECT. INDIRECT. INCIDENTAL. SPECIAL. PUNITIVE. CONSEQUENTIAL OR EXEMPLARY DAMAGES, HOWSOEVER CAUSED, INCLUDING BUT NOT LIMITED TO, DAMAGES FOR INFRINGEMENT ON ANY INTELLECTUAL PROPERTY RIGHTS, LOSS OF PROFITS OR SALES, BUSINESS OPPORTUNITY, LOSS OF REPUTATION, LOSS OF ANTICIPATED SALES, GOODWILL, USE, DATA OR OTHER INTANGIBLE LOSSES (EVEN IF CABWRITER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES) RESULTING FROM: (I) THE USE OR THE INABILITY TO USE THE SOFTWARE; (II) THE INABILITY TO USE THE SOFTWARE TO ACCESS CONTENT OR DATA; (III) THE COST OF PROCUREMENT OF SUBSTITUTE GOODS OR SERVICES; (IV) UNAUTHORIZED ACCESS TO OR ALTERATION OF YOUR TRANSMISSIONS OR DATA; OR (V) ANY OTHER MATTER RELATING TO THE SOFTWARE. THE FOREGOING LIMITATIONS SHALL APPLY NOTWITHSTANDING A FAILURE OF ESSENTIAL PURPOSE OF ANY LIMITED REMEDY AND TO THE FULLEST EXTENT PERMITTED BY LAW

You agree not to bring any suit or action against CabWriter, and/or its subsidiaries and affiliates, officers, employees or agents for any reason whatsoever more than one year after the cause of action arises. The limitations and exclusions set forth in this Section 7 shall not apply to any claim in respect of death or personal injury.

## 8. EXCLUSIONS AND LIMITATIONS

NOTHING IN THIS AGREEMENT IS INTENDED TO EXCLUDE OR LIMIT ANY CONDITION, WARRANTY, RIGHT OR LIABILITY WHICH MAY NOT BE LAWFULLY EXCLUDED OR LIMITED. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF CERTAIN WARRANTIES OR CONDITIONS OR THE LIMITATION OR EXCLUSION OF LIABILITY FOR LOSS OR DAMAGE CAUSED BY NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF IMPLIED TERMS, OR INCIDENTAL OR CONSEQUENTIAL DAMAGES. ACCORDINGLY, ONLY THE ABOVE LIMITATIONS IN SECTIONS 6 AND 7 WHICH ARE LAWFUL IN YOUR JURISDICTION WILL APPLY TO YOU AND CABWRITER'S LIABILITY WILL BE LIMITED TO THE MAXIMUM EXTENT PERMITTED BY LAW.

#### 9. NO THIRD PARTY BENEFICIARIES

You agree that, except as otherwise expressly provided in these Terms and Conditions, there shall be no third party beneficiaries to these Terms and Conditions.

#### **10. MISCELLANEOUS PROVISIONS**

a) Entire Agreement. These Terms and Conditions constitute the entire agreement between You and CabWriter relating to the Software and govern Your use of the Software. This agreement can only be modified if agreed upon by CabWriter and You in writing. CabWriter reserves the right, from time to time, with or without notice to you, to change the Terms and Conditions of this Agreement in its sole discretion. The most current version of this Agreement will supersede all previous versions. Your use of the Software after the changes are made means that you agree to be bound by such changes. Therefore, you should review this Agreement periodically. The official language of these Terms and Conditions is English. If there is a conflict between the English language version and any translation, the English language version will control.

- b) **Waiver and Severability of Terms**. The failure of CabWriter to exercise or enforce any right or provision of these Terms and Conditions shall not constitute a waiver of such right or provision. If any provision of these Terms and Conditions is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavor to give effect to the parties' intentions as reflected in the provision, and the other provisions of these Terms and Conditions shall remain in full force and effect.
- c) **Headings**. The section headings in these Terms and Conditions are for convenience only and have no legal or contractual effect.
- d) **Law and Venue**. This Agreement shall be governed by, and construed and enforced in accordance with, the laws of the Commonwealth of Massachusetts, without giving effect to the principles of conflict of laws thereof. In the event of litigation in connection with this Agreement, the parties agree that such action shall be brought in the state or federal courts located in Boston, Massachusetts. If You or a Permitted User attempts to use, copy, disclose, or transfer any portion of the Software or any modification thereof in a manner contrary to the terms of this Agreement or in derogation of CabWriter's rights, whether those rights are explicitly stated, determined by law, or otherwise, CabWriter shall have the right, in addition to any other remedies available, to seek injunctive relief enjoining such actions without the posting of bond, it being acknowledged by You that all other remedies are inadequate.

#### 11. Upgrades, Updates, and Fixes

CabWriter may provide You, from time to time, with Upgrades, Updates or Fixes, as detailed herein and according to its sole discretion. You hereby agree to keep the Software up-to-date and install all relevant Updates and Fixes, and may, at Your sole discretion, purchase Upgrades, according to the rates set by CabWriter. CabWriter shall provide any Update or Fix free of charge; however, nothing in this Agreement shall require CabWriter to provide Updates or Fixes.

**Upgrades:** For the purpose of this License, an Upgrade shall be a material amendment in the Software, which contains new features and or major performance improvements and shall be marked as a new version number. For example, should You purchase the Software under version 1.X.X, an upgrade shall commence under number 2.0.0.

**Updates:** For the purpose of this License, an update shall be a minor amendment in the Software, which may contain new features or minor improvements and shall be marked as a new sub-version number. For example, should You purchase the Software under version 1.1.X, an upgrade shall commence under number 1.2.0.

**Fix:** For the purpose of this License, a fix shall be a minor amendment in the Software, intended to remove bugs or alter minor features which impair the the Software's functionality. A fix shall be marked as a new sub-sub-version number. For example, should You purchase Software under version 1.1.1, an Update shall commence under number 1.1.2.

### 11. Support

The Software is provided under an AS-IS basis and without any support or maintenance. Nothing in this Agreement shall require CabWriter to provide You with support or fixes to any bug, failure, poor performance or other defect in the Software.

**Bug Notification:** You may provide CabWriter of details regarding any bug, defect or failure in the Software promptly and with no delay from such event; You shall comply with CabWriter's request for information regarding bugs, defects or failures and furnish CabWriter with information, screenshots and try to reproduce such bugs, defects or failures.

**Feature Request:** You may request additional features in the Software, provided, however, that (i) You shall waive any claim or right in such feature should feature be developed by CabWriter; (ii) You shall be prohibited from developing the feature, or disclose such feature request, or feature, to any 3rd party directly competing with CabWriter or any 3rd party which may be, following the development of such feature, in direct competition with CabWriter; (iii) You warrant that the feature does not infringe any 3rd party patent, trademark, tradesecret or any other intellectual property right; and (iv) You developed, envisioned or created the feature solely by Yourself.
